- Open Top Rolloff Containers— For filter cake and tank bottoms generated from on-site dewatering operations associated with presses and centrifuge equipment

- Hardtop Rolloff Containers and Hardtop Intermodal Containers—For waste subject to strict air emission standards and RCRA Subpart CC regulations such as tank bottoms from cleaning operations
- Cubic Meter Containers— Metal and plastic construction for areas where larger size containers cannot be positioned
- Frac Tanks—For on-site storage of process waters and other liquids and used in conjunction with pumps, filtration devices, vacuum and dewatering boxes



• Open Top Intermodal Rolloff Containers—For centrifuge and press operations and the waste generated during these processes that can be transported to an end disposal facility
